# **County Representatives:**

Ashland County Sheriffs Department – not present

Ashland County Board - Gary reported that the Sheriffs Department settled with the Bad River Tribe so they will be patrolling there again as long as the tribe continues to pay their bill. The Ashland/Bayfield Counties joint 911 system is up and running and is the 1<sup>st</sup> joint county system in the state. Nothing to report on the County Board. The timber sales are doing better than expected. Gary will have the numbers soon. Sheriffs Department still has 2 open positions. Butternut School District will have a referendum back on the April ballot. If it fails this time, that will be it and the school will probably by closed down in 2 years. There is only 137 Butternut kids in the school so the state aid is falling every year. It take about 4M annually to run the school.

#### **Unfinished Business/Old Business**

Excavator Head – Don Their estimated that it would be about \$4,000 for him to redo the hitch assembly if we purchase the iron. The Board would like this in writing. For the 2,000 hour maintenance on the excavator, Terry Palecek requested that oil test kits be purchased and samples be taken before the maintenance is done. This way we will know if there is any issues before hand. It was also requested that Darren Weik also do tests on the oil regularly.

#### **NEW BUSINESS:**

Joint Powers agreement – per Ashland County due to the new joint dispatch center, this agreement is no longer necessary.
